For the purpose of Bidders who choose to submit their bid electronically through e-procurement section, may visit e-GP system www.bolpatra.gov.np/egp, the Bidders may purchase the hard copy of bidding documents or may choose to download the necessary part of bidding documents, prepare their bid and submit their electronic bids as specified in the Instructions to Bidders.
